Logistical information

Accommodation (World Cup Rules Art. 13)

- Booking according the FIS Rules via FIS Online registration system
- The OC offers following accommodation (full board included):
 - Three stars hotel max CHF 125 per person in double room,
 - Two stars hotel max CHF 90 per person in double room.

Price for additional accommodation outside of the quota: on request;

Price for additional single rooms outside of the quota: on request.

Transport (World Cup Rules Art. 11)

- Official airport : Munich - Innsbruck - Verona
- The organizing committee will arrange transportation between the airports and the hotels. 1 transport (from and to the airport) free of charge. Price for additional transport: depends on destination. Quotation is available on request.
- Information to the Shuttle service:
no Shuttle service organised by the OC.

Reimbursement (World Cup Rules Art. 10 and 13)

- Accommodation costs: Teams will pay directly in their hotel (persons from the pay lists will be paid by the OC directly to the hotels).
Over quota costs are to be paid by cash or credit card.
- Carrying costs/Reimbursement :
 - Expenses sheets will be received in financial office during the race weekend or by e-mail: Payments will be done by bank transfer.

- Income tax of European citizen is 20%
- Income tax of non-European citizen is 20%

Waxing facilities (World Cup Rules Art. 14)

- Wax cabins : available from 04/01/2019 at 14 :00
- Waxing trucks : teams arriving with trucks have to inform the OC before 12/11/2018, and give all the details about size of the truck and particular needs.
- **Special permissions for truck driving are needed (Sunday- and night, other days with special regulations f.e. January 6th.)**
- The keys of the cabins are available at the waxing cabins compound. Parking permits will be distributed during the 1st. Team Captains' Meeting by the Chief of Competition.

Regulations of radio equipment/Radio Frequencies:

The import, export and the operation of radio equipment in Italy is regulated by national law. Permits for the use of radio transmission equipment must be requested according to national specifications

Regulations of Visa:
