Every person who wishes to access a FIS World Cup Event must present a negative Covid-19 RT-PCR Test result carried out at least 48 hours before arrival/accreditation. The result needs to be uploaded to the FIS Passport as soon as it is available, and every person must complete a Health Questionnaire. The pre-testing requirement is mandatory for all accredited individuals regardless of immunity and vaccination status.

Transport

The official airport is Helsinki airport (94 km from Lahti).

The organising committee will arrange transportation between the airports and the hotels. One free transfer per team from the official airport to the venue and one from the venue to the airport. Teams are required to send the exact arrival times, flight numbers and number of arriving people to the organiser latest eight (8) days before arrival via the FIS Online Entry system. Price for additional transportation: 1-3 persons: 40€/ person, 4-6 persons: 170€/ transfer.

GENERAL COVID-19 INSTRUCTIONS TO ALL ACCREDITED PARTICIPANTS

Lahti Ski Games prioritizes the health and safety of all participants. We follow the Finnish national and local rules and precautions related to Covid-19, as well as FIS World Cup Covid-19 Protocol. The instruction may change on short notice. Up-to-date information is available at www.lahtiskigames.com/. Additional information can be obtained from the event Covid-19 team: covid19@lahtiskigames.com.

All accredited event participants are requested to follow these instructions:

- Make sure you are completely healthy when attending the event. If you have any symptoms related to Covid-19, inform your contact person and stay at home until you are healthy.
- Wear a mask in the event area. Using a mask indoors in the accredited areas indoors is required all the time, as well as outdoors
 when it is not possible to maintain the safety distance to others.
- Take care of safety distances to others whenever possible.
- Take care of good hand hygiene.
- All accredited event participants are required to fill in the pre-event health questionnaire before obtaining the accreditation.

The LOC provides additional health instructions based on the situation and the role of the participant.

TEAM INSTRUCTION

Lahti Ski Games follows Finnish national and local rules and precautions related to Covid-19, as well as FIS World Cup Covid-19 Protocol.

All participants applying for team accreditation are required to

- Present a negative Covid-19 test result (PCR test only) that is not older than 48 hours at the time of retrieving the accreditation.
- Presenting a valid vaccination certificate. In case this is not available, the participant is required to attend additional Covid-19 tests
 during the event every 48 hours, as instructed by the LOC Covid-19 team.
- Filling in the pre-event health questionnaire

All team members are required to register the FIS Passport system and report the required results and certificated within the system. The instructions are available here.

Entry regulations to Finland are available here. Check the entrance requirements depending on your country of departure. In general, travellers arriving from EU / Schengen area not required a test when arriving to Finland. In a post-entry health check vaccine certificate or Covid-19 recovery certificate (less than 6 months old) may be checked, so be prepared to show those.

Arriving from other countries (outside Schengen / EU), typical requirement is to present vaccine or recovery certificate.

The up-to-date way to check the individual entry requirements is to log in <u>Finentry</u> -service and enter your travel details and other requested information. Using the service is not mandatory.

In case you have team members that don't fulfill the entry requirements (e.g. arriving from outside of Schengen without a vaccine certificate approved in Finland), contact <u>covid19@lahtiskigames.com</u> at latest 72 hours before arrival to obtain the required permissions.

ON-SITE TESTING FOR TEAMS

There will be a PCR testing possibility on site (Vesijärvi hall), starting on Tuesday the 22nd February. The testing will be conducted at the participant's cost.

Pre-booking of the tests is required. The tests are booked by sending the reservation excel sheet with the requested testing time to covid19@lahtiskigames.com The testing time will be confirmed by e-mail.

The on-site testing uses PCR tests. The test result is sent both by SMS and the official test result certificate by e-mail. For the tests done before noon, the results will be ready in the evening the same day and for the afternoon tests, the results are ready by next morning.

The price of the test is 195 eur / person. The tests need to be paid at the testing site by credit card.

At the testing site, you need to fill in the consent form for the test results or bring a pre-filled form with you and to show a valid ID.

Regulations of radio equipment/Radio Frequencies

The Finnish Transport and Communications Agency (Traficom) regulates the use of radio frequencies in Finland. Based on submitted applications, Traficom issues radio licences for users of radio transmitters to ensure trouble-free utilisation of the radio spectrum. Applications can be submitted by filling in the form found with the link below no later than 28 January 2022.
